DOCTOR OF LEADERSHIP STUDIES

The Doctor of Leadership Studies (LSD) is a post-graduate professional degree program designed to equip mid-career leaders, managers, and practitioners who wish to refine, refresh, and upgrade their knowledge and skills in leadership and administration. Emphases fall on addressing organization change, designing relevant products, and creating process-based solutions. The program balances theory-assessment with competency-driven courses and project-based outputs. A culminative dissertation is required for graduation.

Program Outcomes

The degree program aims to produce graduates who are able to:

- 1. engage in lifelong learning and understanding of the need to keep abreast of the developments in the field;
- 2. articulate and effectively communicate, orally and in writing, theories in leadership studies to a variety of audience and settings;
- 3. display critical thinking in addressing issues and evaluating existing leadership processes, products, and policies;
- 4. design, innovate, and implement new strategies and means that will lead to the holistic welfare of individuals and communities;
- 5. engage skillfully in planning, negotiating, and implementing policies;
- 6. work effectively and independently, but also in the spirit of servant leadership; and
- 7. adhere to ethical, professional, legal, and Christian standards of work.

Course Delivery Method

Courses will be offered on flexible learning system. This means that each course will have synchronous and asynchronous learning activities throughout the week. Synchronous sessions may be physical or virtual (depending on the circumstances). Attendance is checked during synchronous sessions. Asynchronous learning activities may include doing assigned readings, writing papers, taking quizzes, joining online forum and discussions, performing on-site requirements, and other learning experiences assigned by the professor.

Curriculum Details

The Doctor of Leadership Studies is a full-time, 2-year post-graduate program consisting of 45 units, including Comprehensive Examination and Dissertation. Units are divided among Research Courses, Core Courses, Cognates, and Specialization Courses.
